



FUN 101.7 WLDE OFFICIAL CONTEST RULES
"FOOTBALL AND A FLATSCREEN"

How to Enter the Contest:

Participants may enter the contest between Friday, January 16, 2015 through Wednesday, January 28, 2015, until 4pm. To participate, contestants must register online at www.fun1017.com to receive Fun 101.7 Fun Club emails. If you are already a member of the Fun 101.7 Fun Club and are currently receiving emails from Fun 101.7, you are already registered for the contest.

Any additional locations will be announced on air. Contestants must provide their first and last name, complete email address and zip code to be qualified.

Only one entry allowed per person. Multiple entries submitted will disqualify the entrant. A contestant may only fill out an entry form for themselves, but no one else.

How to Play:

Listen to Fun 101.7 FM each weekday between Tuesday, January 20, 2015 and Thursday, January 29, 2015 between the hours of 7:00am and 7:00pm. Fun 101.7, WLDE will select at least 3 names each weekday at random from all eligible members of the Fun 101.7 Club and announce the contestant's names on air. Fun 101.7, WLDE reserves the right to determine the frequency and times the contest will be played each weekday and the number of contestants selected each weekday. Each contestant whose name is announced on Fun 101.7 will have ten (10) minutes and seventeen (17) seconds from the time of the first announcement of their name to call the Fun 101.7, WLDE studios at (260) 426-5343 or toll free at 1-888-450-1017 to be eligible for the Grand Prize drawing, ("A Finalist"). The person whose name is announced must be the one who personally calls back within the allotted time, to become a finalist and be eligible to win the Grand Prize and win a qualifying prize. No one else may call for that person.

If the person whose name is announced does not call within ten minutes and seventeen seconds from the time their name is announced, he or she will not qualify to win the Grand Prize and will not win the qualifying prize. In the event that two or more individuals with the same name call, only that individual who's information provided identically matches the information on the randomly drawn entry, shall be declared the finalist and will be in the drawing for the Grand Prize and win the qualifying prize.

Eligibility Restrictions:

You must be 18 years of age or older with a valid photo I.D. or other identification issued by the U. S. government or an educational institution. To enter, you must live in the Fort Wayne metropolitan area, consisting of Allen, Whitley, Dekalb, Wells, Adams, Huntington, Steuben, or Noble counties in Indiana or Defiance, Van Wert or Paulding counties in Ohio.
